2) Seller's Representations

- a) As of the date of this agreement, the dog is in good health and free of communicable diseases.
- b) The owner has 72 hours to have dog examined by a veterinarian and to personally inspect the dog. Any claims must be made within this time period and will be verified by Seller's own veterinarian if possible.
- c) Buyer is completely satisfied with and waives any and all claims regarding the dog's conformation, and outward appearance (meaning the dog meets the breed standard at this age).

3) Consideration

This dog identified in Section 1, is being sold for the sum of \$_____, to be paid in full before puppy is released to Buyer. Limited AKC registration application/papers will be transferred to Buyer once the sum has been paid in full.

This puppy comes with Limited AKC Registration papers with no options to upgrade to full AKC registration. The buyer agrees to never breed the dog purchased under this agreement. If the buyer does breed the dog identified in section 1 of this contract. The buyer will pay the seller a fee of \$10,000 for each litter produced by the dog identified in Section 1.

_____ 4) Stipulations

a) If Buyer decides to sell dog or otherwise place him/her elsewhere, Seller gets first chance to reacquire dog according to terms agreed to by Buyer and Seller at that time. (For NO MORE than original price.)

b) We will take back ANY Reginhard puppy/dog at ANY time at NO expense to the seller. We have an open “come home” policy (if for any reason Buyer cannot care for or house puppy/dog).

c) Buyer agrees that the seller of Reginhard German Shepherds CAN and WILL REPOSSES said described dog/puppy upon the EVIDENCE OF ABUSE / NEGLECT at NO expense to the seller. That the buyer agrees to NEVER place the said dog/puppy in an Animal Shelter, or sell to a PET store or a PUPPY MILL (breeders who mass produce puppies) or leave puppy/dog tied outside to live its life on a chain.

_____ 5) Limitation of Contract

This contract applies to the original dog owner only and is nontransferable to a secondary party. Buyer is responsible for all transportation costs to or from vet or Reginhard German Shepherds.

_____ 6) Health Warranty

Puppies need much less exercise than fully-grown dogs. If you over-exercise a growing puppy you can overtire it and damage its developing joints, causing early arthritis. A good rule of thumb is a ratio of five minutes exercise per month of age (up to twice a day) until the puppy is fully grown, i.e. 15 minutes (up to twice a day) when three months old, 20 minutes when four months old etc. Once they are fully grown, they can go out for much longer.

a. There are no guarantees for ears standing, testicles dropping, heart murmurs, or herniated umbilical cords.

b. Buyer agrees not to engage in endurance activities or training agility work, downhill work, stairs, or hard surface running until the puppy is at least 12 months of age, as these activities can affect skeletal growth and development.

c. The puppy will have all vaccinations current to age and will have been wormed at proper intervals according to age. If the puppy becomes sick, is injured, or dies/needs to be put to sleep for any reason other than those stated in the guarantee after the initial 72 hour period, the seller has no obligation to replace the puppy and will be relieved of all responsibility to do so.

d. If puppy/dog, male or female, is bred before the age of 2 years, this contract is null and void.

e. If puppy/dog is spay/neuter before the age of 12 months, this contract is null and void. We recommend waiting until at least 18 months of age for your dog's health.

_____ 7) All puppies/dogs will be registered with the “von Reginhard” name at the end of their AKC name. The first name is to be decided by the seller followed directly by the “von Reginhard” name. This is so I can keep track of all my puppies produced by me within my breeding program of Von Reginhard. If my kennel name or the Given Name as assigned to this said dog is NOT used then this contract becomes NULL and VOID!!!

____ 8) Shots and de-worming records have been given to the buyer along with the puppy's Limited AKC Registration application and puppy care package. **** Reminder**** You must fill out your puppy's Registration application and send it in to AKC for your puppy to become registered with the American Kennel Club.

____ 9) From this day on buyer agrees to assume all cost for veterinarian and all other health related needs of this described dog/puppy while in the buyer's possession. The buyer shall assume full responsibility for health, anatomical make up of this described dog/puppy from this day on.

____ 10) Once said puppy/dog leaves from Reginhard German Shepherds we no longer have control over the temperament, as we no longer have control over the type of the environment for which the dog/puppy is raised in. Dogs and puppies can develop temperament issues as a result in the way that they are raised which is a learned behavior that we have NO CONTROL over; therefore, there will be NO temperament guarantee. I do NOT guarantee the working ability of any puppy. The buyer agrees to relieve the seller of any and all liability with the puppy. It is also agreed that the seller is relieved of any and all future liability of any kind associated with the puppy/dog.

____ 11) This constitutes the full agreement of the parties. There are no guarantees or warranties either expressed or implied beyond what is stated in this contract. I the breeder, Reginhard German Shepherds LLC has done everything within my power to provide you with a well-bred healthy puppy/dog characterized by physical and mental soundness.

____ 12) This agreement shall be construed under and in accordance with the laws of the state of Ohio and the venue for any legal action arising out of this agreement shall be in Knox County, Ohio, or the current residing county of the seller. Wherefore, the above-named seller and buyer have executed the forgoing contract of sale at _____ AM/PM on this day of _____ .
